COVID-19 Guidelines for Facility Rentals

Novel Coronavirus Disease 2019 (COVID-19) is a severe acute respiratory illness that is contagious, and is believed to spread mainly from person-to-person contact. COVID-19 has been declared a worldwide pandemic by the World Health Organization. On March 9, 2020, Governor Ron DeSantis declared a state of emergency for the entire State of Florida as a result of COVID-19. On March 17, 2020, the St. Johns County Board of Commissioners declared a local state of emergency as a result of COVID-19.

In accordance with Governor DeSantis' Executive Order Number 20-139, Full Phase 2: Safe. Smart. Step-by-Step. Plan for Florida's Recovery and in addition to applicable policies governing their use, the following guidelines will be implemented to allow the rental of all St. Johns County Parks and Recreation indoor facilities and outdoor spaces for gatherings and community events.¹

Responsible Individual Activity

- All guests and attendees are encouraged to follow appropriate <u>social distancing and</u> <u>safety protocols</u> issued by the Centers for Disease Control and Prevention (CDC).
- Senior citizens and individuals with a significant underlying medical condition are strongly encouraged to avoid crowds and take measures to limit the risk of exposure to COVID-19.
- All guests and attendees traveling from areas with substantial community spread as identified by Governor Desantis through <u>executive order</u> (currently CT, LA, NJ and NY) must follow all applicable isolation or quarantine protocols.
- All guests and attendees who work in health or long-term care facilities should betested for COVID-19 on a routine basis.
- All guests and attendees are encouraged to follow the CDC's guidance on how to protect themselves and others from the spread of COVID-19.

¹ St. Johns County will review these guidelines weekly, and make updated changes as necessary. You will be provided with a copy of the most current guidelines prior to each rental of an indoor/outdoor facility. You will also be required to complete an Acknowledgement of Risks and Waiver of Liability prior to each rental.

Guidelines for Indoor Rental Spaces

- Attendance for gatherings and community events held at indoor facility rooms, (e.g., meeting rooms, conference rooms, etc.) will be limited to 50% of the room capacity, and may not exceed 50 people regardless of room size.
- Attendance for gatherings and community events held at indoor gymnasiums and fitness centers will be limited to 50% capacity, with appropriate social distancing and sanitation protocols.
- Use of each indoor rental space shall be limited to one gathering or community event per day to allow for appropriate cleaning, disinfecting and sanitizing between uses.
- Following use of each indoor rental space, Staff will clean and disinfect frequently touched surfaces (e.g., door handles, sink handles, drinking fountains, and tabletops) within the facility.

Guidelines for Outdoor Rental Spaces

- Attendance for gatherings and community events held at outdoor facilities (e.g., pavilions, arenas, ball courts and open spaces) will be limited to no more than 50 people, with appropriate social distancing.
- Daily use of each outdoor rental space shall be limited to allow for appropriate cleaning, disinfection and sanitation between uses.
- Following use of each outdoor rental space, Staff will clean and disinfect frequently touched surfaces (e.g., drinking fountains and tabletops) within the facility.

Acknowledgement of Risk

Any person seeking to rent an indoor or outdoor facility will be required to sign an Acknowledgement of Risk and Waiver of Liability stating that they understand:

- 1. the terms and conditions contained in these guidelines for facility rentals;
- the CDC has provided information explaining how COVID-19 is spread and that the best way to prevent illness is to avoid being exposed to the virus, which is found at https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html;
- 3. the CDC's guidance for protecting against the spread of COVID-19, which is found at https://www.cdc.gov/coronavirus/2019-ncov/prepare/prevention.html;
